INVESTMENT TYPES

We offer three major types of investment

One time investment: a one-time investment refers to a single, lump-sum amount of money that is invested in a particular project, sector with the expectation of generating returns over trading period without reinvestment. Profit plus capital will be available for use after the trading period without automatic reinvestment.

Reinvestment of capital: Reinvesting capital alone without profit means automatic Investing back the initial capital after trading period while leaving your profit at the available balance for immediate withdrawal or personal use. Capital will be automatically reinvested without your earnings for another trading period.

Reinvestment of profit plus capital: Reinvesting both the profits and the initial capital in ROI means putting back any returns or profits earned from an investment, as well as the original amount of money invested, back into the same investment. This can further increase the potential for compounding returns and potentially lead to even greater overall returns over time.
